CHIEF JUDGE ORDER 21-07 REGARDING COURT OPERATIONS BEGINNING JUNE 1, 2021		

On May 13, 2021, the Centers for Disease Control and Prevention updated its guidance for fully vaccinated people by significantly reducing mask and social distancing recommendations. This update did not change the protective steps unvaccinated people should continue to take.

On May 14, 2021, Governor Polis amended his Covid-19 order to allow fully vaccinated people to go without masks in public indoor places, subject to certain exceptions.


On May 14, 2021, the Colorado Department of Health eliminated social distancing requirements for groups of 100 or fewer in indoor settings.

On May 17, 2021 Chief Justice Brian Boatright issued his Order Regarding Safety in Colorado Courthouses, which continues the requirement that all people in the public areas of Colorado Courthouses wear masks until June 18, 2021. This order leaves it to each Chief Judge to consult with local health authorities to decide what social distancing requirements should be continued.

Since Fourth Judicial District CJO 21-06 issued on May 4, 2021, the Covid-19 incidence numbers have been slowly declining, as shown in the graphs on the following page:



As of May 17, 2021, 35.8% of El Paso County residents are fully immunized. In Teller County, 40.7% of residents are fully immunized.

In preparing this order, I have also consulted with the El Paso County Health Department regarding a gradual return to pre-pandemic operational levels.

Unlike private businesses—which individuals choose to visit—the courts require significant numbers of people to attend court proceedings every day. Among those required by law to come to court are citizens summoned for jury duty.

In light of the above information, to ensure the safety of everyone coming to the El Paso County Courthouse and Teller County Combined Courts, and pursuant to the authority granted in Chief Justice Brian Boatright's May 17, 2021 Order Regarding Safety in Colorado Courthouses and Chief Justice Directive 95-01, IT IS HEREBY ORDERED:

- That anyone in public areas of the El Paso County and Teller County Combined Courts shall continue to wear masks until July 2, 2021.
- Beginning June 1, 2021, anyone in the El Paso County Courthouse and Teller County Combined Courts shall maintain three-foot distancing from those who are not members of the same household.

¹ Consistent with Governor Polis's order (D 2021 103), this mask requirement does not apply to children ten years old and younger or to people who cannot medically tolerate a face covering.

Furthermore, since April 2, 2021, all adult citizens in Colorado have been eligible to obtain a Covid-19 vaccination. By July 6, 2021, any adult wanting to be fully vaccinated for Covid-19 will have had sufficient opportunity to do so. Depending on the course of the pandemic over the next six weeks and any new orders issued by Governor Polis, Chief Justice Boatright, or the Colorado Department of Health in the meantime, the Fourth Judicial District courts intend to resume normal or near-normal operations starting July 6, 2021, with masks required only for those who are not fully vaccinated.

- 1. Courthouse Operations: The El Paso County Courthouse and Teller County Combined Courts will remain closed to the public <u>EXCEPT</u> as to:
 - A. Contested evidentiary hearings and trials in <u>Criminal and Juvenile</u>
 <u>Delinquency cases</u> where mask and social distancing requirements can be strictly complied with, both in the courtroom and in any hallway;
 - B. Sentencing hearings where mask and social distancing requirements can be strictly complied with, both in the courtroom and in any hallway;
 - C. Contested evidentiary hearings and trials in <u>Domestic Relations</u>, <u>Probate</u>, <u>and Juvenile cases</u> where mask and social distancing requirements can be strictly complied with, both in the courtroom and in any hallway;
 - D. Probation supervision matters where the Probation Department or a Probation Officer has requested a meeting in person and where mask and social distancing requirements can be strictly complied with; and
 - E. Exceptions set forth in "Teller County Court Covid-19 Order re: Evictions and Civil Cases;"
 - F. Exceptions set forth in Section 6 of this order;
 - G. This order does not affect Division CVL's Operating Order.
- 2. ALL OTHER COURTROOM PROCEEDINGS shall occur by Webex or telephone, except as set forth in Section 6 of this order.

3. For only those public safety filings listed in Section 6 of this Order, the El Paso County Clerk of Court's Office will be open from 8 a.m. to 12p.m. and 1:00 p.m. to 4:30 p.m., Monday through Friday, with the exception of legal holidays. The Teller County Clerk of Court's Office will be open from 8 a.m. to 4:00 p.m., Monday through Friday, with the exception of legal holidays. All other paper filings shall be mailed directly to the courthouse, dropped into the drop-off box at the main entrance to the El Paso County Courthouse, or e-filed through the Colorado Courts E-filing system (CCE).

4. JURY TRIALS

Jury trials shall continue as they have, until June 1, 2021.

Starting June 1, 2021 and ending July 2, 2021, the El Paso County Courthouse will be able to accommodate the following trials:

- a) Two to four felony jury selections each day Monday through Thursday;
- b) Two misdemeanor jury selections each day Monday through Thursday;
- c) One CV jury trial Monday and one CV jury trial Tuesday in what was formerly the Metro jail; and
- d) One JV jury trial Wednesday and one JV jury trial Thursday in what was formerly the Metro jail; and
- e) Every day of the week, a large panel of jurors (up to 80) will be available for singleday jury selection in the Jury Assembly Room for first degree murder cases and other similar trials requiring large panels.

Starting June 1, 2021, the Teller County Combined Courts may conduct the trials it is able to following the three-foot social distancing and mask requirements.

5. Parties without attorneys shall contact the court clerk for the division where their case is pending to receive further directions. A list of division phone numbers is attached to this order. A list of the Court's division phone numbers can also be found at:

In leaving any voicemail message, parties without attorneys shall include their first and last names, their phone number, their email, and a case number, if available.

Defendants may also contact division staff by sending an email to the Court at 4thclerkofcourt@judicial.state.co.us. Email correspondence will then be forwarded to the appropriate division.

Failure by an unrepresented criminal defendant to contact the division clerk by Webex, phone, or email within 24 hours after any scheduled court date may result in the issuance of an arrest warrant.

If the division clerk gives an unrepresented criminal defendant a new court date by telephone, the division clerk shall order the defendant to appear by Webex or telephone on that next court date. Any such defendants shall immediately notify their bondsmen that their bond has been continued until the next court date.

Any bondsman who objects to any procedure of continuing bonds set forth in this Order shall promptly communicate in writing to Chief Judge Bain the nature of the objection.

6. Public Safety Matters: The El Paso and Teller County Combined Courts will continue to accept filings and conduct hearings on public safety matters. Whenever practical, these proceedings shall occur by Webex or phone.

Public safety matters are **limited** to the following:

- **A.** Petitions for temporary civil protection orders and permanent protection order hearings;
- **B.** Petitions and hearings for temporary emergency risk protection orders and emergency risk protection orders;
- C. Crim. P. Rule 5 advisements (bonded or video advisement in the duty division);
- **D.** Revocation hearings on complaints to revoke probation involving an incarcerated defendant;
- E. Proceedings necessary to protect the constitutional rights of criminal defendants, including bond-related matters and plea agreements for incarcerated individuals;
- F. Juvenile detention and advisement hearings for juvenile delinquency cases;
- G. Shelter hearings in dependency and neglect cases;
- **H.** Petitions for appointment of an emergency guardian and/or special conservator and hearings related to same;
- I. Hearings on motions to restrict parenting time and parental abduction prevention;
- J. Emergency mental health filings and proceedings; and
- K. Other proceedings deemed necessary and exceptional by the Chief Judge.
- 7. Social Distancing: When hearings or trials under Sections 1, 4, or 6 of this order are conducted anywhere in the El Paso County or Teller County Combined Courts, judicial officers and court staff shall reasonably limit in-person participation and shall follow all mask and social-distancing requirements.
- 8. Self-Help Centers: The self-help center at the El Paso County Courthouse is closed to inperson help until further notice. All court forms and instructions can be found at https://www.courts.state.co.us/Self Help/Index.cfm. For additional assistance or to schedule a virtual self-help session, email 04SelfHelp@judicial.state.co.us or call (719) 452-5100.

9. Probation: The probation staff is conducting most business by phone or video call your Probation Officer directly email conferencing. Please firstname.lastname@judicial.state.co.us, or you can contact the Probation Department main office at 719-452-5900 or 04probation@judicial.state.co.us. If the court or someone from probation has informed you to report in person, our lobby hours are Monday-Friday from 8:00am-5:00pm. Voicemails and emails are checked daily; when leaving a message, please indicate the level of urgency of your situation. Due to a high volume of calls and emails, please allow 24 hours for a response prior to contacting the Probation Department again.
